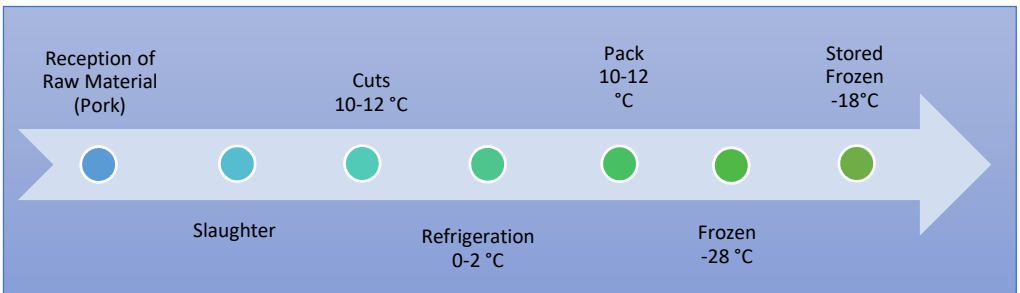

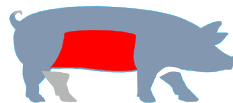


### 1.3 PRODUCT DESCRIPTION:

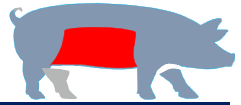

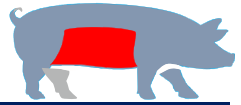
